Activity Classification	Type of Activity	Brief Description
#10	Educational Institution Career Days	The Station has participated in two career days at Alabama State University in the last year. These events enable the stations to disseminate information as to employment opportunities in broadcasting.
#9	Internship Program	The Station accepts intern and practicum students majoring in Communications at Alabama State University and assists them in acquiring the skills needed for broadcast employment.
#7	Scholarship Program	The Station has participated in a journalism scholarship program designed to assist students interested in pursuing a career in news broadcasting.
#4	Community Events	The Station has participated in four career days for children in the Montgomery Public School System to interest them in broadcast employment.
#6	Other Programs Outreach	The Station promotes general outreach through its provision of station tours to prospective university students; the provision of "shadowing" opportunities to students in the Montgomery Public School System; and, through its participation in community events sponsored by such organizations as the Chamber of Commerce.
